Administrative Comments – B. Rist

- General Faculty Meeting: October 12 at 3:15 in DH 1113 or 1114
- DLP Developments:
 - Dr. Ron Hawkins was named the Vice-Provost for Graduate Studies and DLP in the Spring 2006
 - o General Guiding Principles for new DLP Developments:
 - Transparency: the aim is to be transparent with the faculty at LU
 - Quality: courses and programs have improved with the new developments.
 - 8 week format for most courses
 - Increased interaction between faculty and students
 - Reduced section sizes (20-25 for graduate courses / 25-30 for undergraduate courses)
 - o Adjunct professors are screened both academically and spiritually
 - Must sign a Liberty University Statement of Principles, which is based on LU's core values
 - Undergraduate Academic Council for Distance Learning Programs has been established

- Council consists of full-time DLP faculty and Associate Deans for DLP within each school
- A proposed draft of the Constitution of the Undergraduate Academic Council for Distance Learning Programs has been created
- Council will oversee development of undergraduate curriculum for DLP
- Rationale for development of a new council is in line with the rationale that led to the creation of the Graduate Faculty Council
- The process for curriculum development will continue to be faculty-driven
- o SACS has remained informed of all new developments within DLP
- o Bottom line:
 - DLP is committed to growth, but not growth at all cost
 - Growth will be supported by an appropriate number of faculty and staff
 - Dr. Rist has full confidence in Dr. Hawkins as the Vice-Provost for Graduate Studies and DLP
 - Dr. Rist would not be involved in something that would jeopardize the University
- Any questions can be directed to Dr. Rist, Dr. Hawkins, or the Faculty Senate Executive Committee
 - Dr. Rist and Dr. Hawkins are willing to address faculty at individual school's meetings

Undergraduate Curriculum Committee – K. Prior

Change in Titles to the following courses:

MUSC 184 *Marching Band I* 1 hour

Open to any student with previous experience on a woodwind, brass, or percussion instrument. No audition is necessary for Marching Band. During the fall semester, the Band marches at home and selected away football games and in various parades. Lab fee.

MUSC 484 Marching Band II 1 hour

Prerequisite: 4 semesters of MUSC 184 and/or MUSC 194.

Continuation of MUSC 184. Lab fee.

MUSC 183 Jazz Ensemble I 1 hour

Prerequisite: Fall audition, co-enrollment in MUSC 184, MUSC 484, MUSC 194, or MUSC 494.

An auditioned ensemble specializing in jazz ensemble repertoire. Reading and musical interpretation of jazz rhythms and notation are stressed. Improvisational and ensemble skills are developed. The ensemble performs frequently on and off campus.

MUSC 483 Jazz Ensemble II 1 hour

Prerequisites: Fall audition, co-enrollment in MUSC 184, MUSC 484, MUSC 194, or MUSC 494, in addition to 4 prior semesters of enrollment in MUSC 183. Continuation of MUSC 183.

MUSC 194 Wind Ensemble I 1 hour

An auditioned ensemble specializing in advanced instrumental repertoire. The ensemble prepares for an extensive concert tour in the Spring, annual Spring Concert, and other local performances. Lab fee.

MUSC 494 Wind Ensemble II 1 hour

Prerequisite: 4 semesters of MUSC 194 and/or MUSC 184. Continuation of MUSC 194. Lab fee.
