### **Exciting Changes for School Counseling Program**



Liberty's School Counseling Program is growing in exciting ways! Additional courses have been added to the curriculum specific to the specialty of professional school counseling. The newly developed course EDUC 611, Child and Adolescent Counseling in the Schools, (replaces COUN 611/620) began spring 2012. The plan is to launch the newly developed EDUC 512, Structured Groups, in the summer of 2012 (replaces COUN 512), which will cover core group counseling theories and techniques while emphasizing group work in elementary and secondary schools. The addition of school counseling specialty courses means more targeted training as students prepare to engage in counseling minors in the school setting.

Here are some preparation tips:

- ⇒ Read the School Counseling Program Handbook on Liberty's graduate online advising guide.
- ⇒ Follow the proposed course sequencing guide—try to take EDUC 661 as your first intensive course and as early as possible.
- ⇒ Begin now, planning a strategy that will allow you to serve a 300hour internship in two settings (elementary and secondary) in one 16-week semester—for some this may mean permissions and advanced notice to employers, child-care preparations, family communication and role adjustments, and leaves of absence from work).
- $\Rightarrow$  Students must complete all core counseling and school counseling courses PRIOR to internship.
- ⇒ Students must purchase LiveText (do this upon entry into the program so you will have access by the time your course work begins—this is a one-time purchase).
- $\Rightarrow$  Students must complete the background check (do this upon entry into the program so you will be prepared for courses that include field experience).
