V. Course Objectives/Requirements

- 1. The student will be exposed to a variety of concepts and social science approaches to the study of international relations.
- 2. The student will learn how to analyze and compare the history, geography, economies, governing institutions, and political behavior of contemporary nations, states, and international entities.
- 3. The student will thereby become better equipped to understand, participate in, and evaluate international political processes.

VI. Graded Requirements

- 1. Each student is responsible for completing reading assignments prior to class and should keep a loose leaf notebook of class materials.
- Participation is an essential part of class. Textbook chapters, collateral readings, and current events will be the subject of class commentary and discussions.
 Students should be prepared to discuss textbook readings and current events.
- Students will be tested on the lecture and reading material through a series of six tests that are to be taken at the scheduled date and time. Students who will be absent due to some university sponsored activity must arrange to take the test in

- the Testing Center, preferably before but no later than the day after the test is scheduled.
- 4. A pass/fail American map test is scheduled for February 4. The lowest test score will be dropped upon satisfactory completion.
- 5. **Optional**: Students who miss a regular test **or** fail a map test may take a test on Wilbur Zelinsky's <u>The Cultural Geography of the United States</u>, all but chapter four. The lowest test score will be dropped upon completion so long as five test scores remain.
- 6. Honors students may fulfill their honors requirements by reading the lengthy section on state and local government in James Bryce's <u>The American</u> Commonwealth and writing an 8-10 page summary and evaluation.
- 7. The grading scale is 100-90=A, 89-80=B, 79-70=C, 69-60=D, 59 and below=F.
- VII. Attendance Students are supposed to arrive on time for every class meeting. Students who are absent due to illness or emergency should notify the professor prior to class or soon afterward. Excused absences include participation in university-sponsored events, serious illness (if accompanied by a physician's note), or a family emergency. Six unexcused absences may result in a failing grade. Persistent tardiness will have a detrimental effect on grades.
- VIII. Dress Code Observe the Liberty Way. Students who are not in appropriate campus attire will **not** be admitted to class. Caps will **not** be worn in class. Other than drinks, there will be **no** eating in the classroom.
