DESCRIPTION

A study of legislative behavior in the American political system. Included is a study of representation, selection of legislators, organization and procedures of legislative bodies, and the relation of the legislative to the executive and judicial branches.

REQUIREMENTS

- 1. Each student is responsible for assigned readings and should keep a looseleaf notebook of class materials.
- 2. Participation is an essential part of class. Reading assignments should be completed before the class meets. Be prepared to discuss textbook material, report on assigned articles (from Dodd, et al.), and review current events.
- 3. Attendance is required. A week's absence may be excused, but lengthy absences or erratic attendance will have a detrimental effect on grades. If you expect to miss class, please notify me through the school before class meets.
- 4. Students will be tested on the lecture, reading, and discussion material through two short answer and essay exams.
- 5. Each student will write a 4-5 page book abstract or two 2-3 page journal article abstracts, typed and double-spaced. Due May 9.
