STATE AND FEDERAL GOVERNMENT I

DESCRIPTION

A study of the federal and state constitutions and governments with emphasis on elections, political parties, and interest groups. Meets the requirements for Texas teacher certification.

REQUIREMENTS

- 1. Each student is responsible for assigned readings and should keep a looseleaf notebook of class materials.
- 2. Participation is an essential part of class. Reading assignments should be completed before the class meets. Be prepared to discuss textbook material, readings, and current events.
- 3. Regular attendance is required. Lengthy absences (more than one week) and erratic attendance tend to affect grades. Exams must be taken at the scheduled date and time.
- 4. Students will be tested on the lecture, reading, and discussion material through three objective exams. Each exam represents 30% of the grade.
- 5. Three or four pop quizzes will be given on the reading material. The lowest score will be dropped. Together the quizzes represent 10% of the grade.
- 6. Each student will take a pass/fail political geography quiz.
- 7. For up to two points extra credit, students may write two 2-3 page article abstracts, typed and double-spaced. The first abstract is due October 31 and the second is due November 21. Do not use plastic covers or tabs.
