DESCRIPTION

An examination of American legal institutions and processes, with particular emphasis on courts and judicial behavior.

REQUIREMENTS

- 1. Each student is responsible for assigned readings and should keep a looseleaf notebook of class materials, including notes for discussion of readings.
- 2. Participation is an essential part of class. Reading assignments should be completed before the class meets. Be prepared to discuss textbook material and readings. Each student occasionally will lead discussion of specific assigned and supplementary readings.
- 3. Regular attendance is required. Lengthy absences (three sessions or more) and erratic attendance will result in lower grades. Exams must be taken at the scheduled date and time.
- 4. Students will be tested on the lecture, reading, and discussion material through two short answer and essay exams. (40% apiece)
- 5. Each student will make an oral presentation (10-20 minutes) on a topic related to the American legal system. Presentations will be scheduled in November or December, and are to be accompanied by a 5-7 page brief, typed and double-spaced. Do not use plastic covers or tabs. (10%)
- 6. Each student will write a 5-7 page book abstract (10%) or two 2-3 page journal article abstracts (5% apiece), typed and double-spaced. Due December 6.
