Sacrificing Liberty for Security

## Introduction

There has been much discussion over the years about utilizing evidence-based practices and programs, but despite its importance on the subject matter, is still lacking in many evaluations and re-evaluations of justice programs at various levels of governance.<sup>1</sup> As with many terms in the justice and academic-related field, such as *intelligence*, *security*, and *evidence-based* can become politicized in a way that deviates from its original proposal or plan of a program that can waste federal, state, or local monies.<sup>2</sup> Thus, evaluators must have adequate knowledge and coordination with agencies as it relates to the sharing of program funds to ensure that it is not being wasted or abused.<sup>3</sup> The quality of evaluation on programs depends on the skills of the employees and resources granted by the organizational stakeholders.<sup>4</sup> Yet too often, many organizations tend to miss its mission statement, procedures, and regulations as it relates to United States laws—as seen with the federal government’s response in the past year or two by following the guidance of a private organization that is owned by major domestic and foreign pharmaceutical companies and corporations that make its money from supposed *vaccine* manufacturing.<sup>5</sup> The following paragraphs will discuss the degradation of liberty in the United States and the world by promoting a false sense of security. Also, a biblical worldview will be explored.

### Institutions and the Bio-Security-State

Due to the vast size of some agencies in the United States government, bureaucracies tend to have more demanding levels of management and can create a *revolving door mentality* that means regulators move to work for the agencies that they were regulating after leaving their federal jobs.<sup>6</sup> In the context of the United States justice system, much of the increasing regulations and rules or laws have still been unable to completely reduce waste and abuse of federal, state, and local funds during the information operation of a disease that began around March 2020, and plays out identically with globalist white paper documents.<sup>7</sup> Additionally, the recent shutdown peddled by the mainstream media propagandists is highlighted from the Tavistock Institute's *Event 201* with groups like the World Economic Forum, Bill & Melinda Gates Foundation, and Johns Hopkins Center for Health Security being among them.<sup>8</sup> Some of which have accepted grants from EcoHealth Alliance Inc—the same group that was involved with the National Institute of Health (NIH) in sending millions of U.S. federal monies to conduct unethical experiments at foreign labs based reportedly in China that is linked to either accidental or intentional leak for a global eugenics program.<sup>9</sup> Notwithstanding the program being started by

the Obama/Soebarkah administration, unaccounted funds from big pharmaceutical corporations using U.S. government dark money is nothing new as is over-classification to cover up wrongdoing and malfeasance or negligence.<sup>10</sup>

Instead of admitting responsibility, many of the organizations continue to push for more lockdowns, shots, and coercion of employees while denying reasonable accommodation or exception requests by wrongfully terminating employees or pensions and compensations.<sup>11</sup> U.S. funding grants to various organizations under the banner of *covid relief funds* through programs like Medicare/Medicaid, Small Business Administration's (SBA) Payment Protection Program (PPP) loans, reliance on computers, and the rest have led to an increasing amount of waste and abuse of funds through technology scams.<sup>12</sup> Some of these *technology scams* that have existed for decades have recently been growing in its use, including an increase of phishing, selling of counterfeit products, miss advertisements, cyber-intrusions, and poor cyber-hygiene.<sup>13</sup> Speaking of cyber-hygiene and health scams worldwide, foreign adversaries have been given many opportunities to exploit the already fragile state of medical devices created by off-shore companies relating to the monitoring of U.S. citizens such as the recording of DNA and their

vitals remotely after connecting to the Internet using bio-organic nano-parasites in Covid shots.<sup>14</sup>

It is easy to discuss the importance of accountability and proclaim hopes in any organization, whether it be non-profit, corporate, faith-based, government, or military, but *hope is not a plan*.

Moving into the subject of management, the popularized business culture utilization of diversity, inclusion, and equity (DIE) has become politicized because it promotes division, favoritism, and its mandates create more conflict in the workplace by damaging economic gains such as selectively promoting certain supposed minority racial groups above others—which by definition—is illegal.<sup>15</sup> Despite the increased funding into Nanny-state surveillance programs like the Israeli-Mossad backed third party private security Silicon Valley firms post-9/11, the security apparatus is still unable to reduce or prevent terrorism as seen with the recent Waukesha Christmas Parade massacre where the Black Lives Matter connected, Darrell Brooks, was released less than a week on \$1,000 bail due to an extensive previous criminal record before plowing a vehicle into a crowd of people.<sup>16</sup> Similar to the misperception of safety and security

that the Transportation Security Administration (TSA) gives after its rough start at creation post-9/11,<sup>17</sup> Big tech companies like Israel's MITRE Corporation, along with various other groups, pushed for the creation of SMART health cards that utilize a Vaccination Credential Initiative (VCI).<sup>18</sup> Many of the individuals involved in the development of recording and monitoring vitals of citizens across the globe include many globalist organizations such as the World Economic Forum, Rockefeller Foundation, Goldman Sachs, United Nations, BlackRock, pharmaceutical people, former CDC people, and other unelected bureaucrats promoting an international surveillance network at the cellular level in real-time using artificial intelligence sending the data to third parties.<sup>19</sup> One article by Webb states that the program was supporting a biometric identification system known as *ID2020* that was developed in Myanmar and backed by Bill Gates' Microsoft, Commons Project Foundation, and various non-profit/philanthropy spaghetti groups.

### Reliance on Outsourcing

Outsourcing, whether it is with training foreign nationals in American laboratories, universities, military academies, or imports/implants, companies, and globalization with the Internet is increasingly convenient. Many seem to miss the connection between outsourcing and later reported breaches in internal systems, such as the recent leaking of Oracle BlueKai data in 2020 that utilizes sensitive U.S. government contracts to name a few. Many factors can

contribute to the leaking of data, whether it be insider threats, sabotage, poor cyber hygiene, programs by design, or false promises in the security of its management systems developed by third parties that do not have the interest of the United States as a priority.<sup>20</sup> It is not surprising, to see legitimate security concerns arise due to too much reliance on outsourcing government systems to non-American developed programs backed by private mega-corporations bent on surveilling every man, woman, and child, via *vaccination* identification biometrics in real-time only to not improve the well-being but instate a totalitarian technocratic Nanny-state. The same cautions apply when discussing U.S. intellectual property and other critical infrastructures.<sup>21</sup>

Business ethics and moral principles contribute to the way an organization conducts business like the way true followers of Christ adhere to the Bible.<sup>22</sup> Take, for instance, BlackRock's outsourcing to China on investments that in turn are managed by Chinese communist companies subject to the national security law that requires it to collaborate with its military.<sup>23</sup> Some of the top lead underwriters of the Alibaba Group include Goldman Sachs, JP Morgan and Chase, Morgan Stanley, Citigroup, Deutsche Bank, Credit Suisse, Merrill Lynch, UBS, and many others.<sup>24</sup> The Bible describes the worship of money as the root of all evil and the

same concept applies to the worship of man over God.<sup>25</sup> In the context of the material, mega-corporations tend to sell out America in exchange for quick profits—also known as bribery.

In biblical contexts, when Samuel’s sons became corrupt judges and were a disappointment like David’s son, Absalom, that led to civil war due to dysfunctional handling of family conflicts.<sup>26</sup> When discussing issues facing the United States today, much of the dysfunctional organizations in governance can be attributed to low performance and personal conflicts with the people running the organizations.<sup>27</sup> That is, there are consequences when the wrong people are put into the wrong positions.
